The spotter's job is to redirect the climber's fall to try to help them to land on their feet first and/or to assist in protecting the boulderer and may not prevent an injury. Your voluntary participation in this event indicates your acknowledgement that bouldering and spotting are dangerous and that the spotter may not prevent an injury resulting from a fall. You further agree not to engage in flips, tricks, jumping, or any other activity that is not safe in connection with bouldering.
